Old Business:

- 1. Review of Snack/Party Practices Will further when we have more in attendance to facilitate discussion

New Business

1. LGH Wellness Updates (Sue Lackmann)

-Commended our district's progress with Trauma based education

-Working on setting up a tween (11-15 year olds) cooking class at SECA, around March/April, cost is \$40 for an 8 week course. Discussed higher up front cost, but an 8 week program on nutrition for this age group would be beneficial

-Sue also shared her increased need to focus on the rising opioid crisis in county, but then more specifically we discussed the juuling in student populations. Discussed lack of quality educational programs for students and families on juuling, and the serious need for education.

Per Dr. Bliss, we continue with high tobacco occurrences in our schools, related to the rural population, but more so (smokeless) tobacco than juuling yet.

2. Upcoming High School Events (Becky Taylor)

Attending webinar (1/17) with students to learn how to create a marketable public service announcement.

Becky sent in an application to participate in a contest that has students creating a public service announcement that addresses distracted driving. Since she runs the Act Out Loud program, she thought it would be a great way to further involve students in preparing for Act Out Loud. Only 8 Lancaster county positions were available and they accepted our application (had to describe what we were doing in school regarding teaching about distracted driving). Once the application was accepted, we received a check for \$500.

1st prize will be either \$10,000 or a driving simulator

2nd prize is \$5,000 3rd prize is \$2500

The PSA will be submitted in early February. I believe the award comes out early March. -Also, in December, they ran a T shirt logo design contest for 'Act Out Loud'

The design was to be a logo that promotes "Get There Safe" and will be on shirts for all volunteers who will be helping out at the event to wear
