Mr. Steve P. Risk, Board President, called the meeting to order and presided. Monica Miller was present to record the minutes.

Student Accident Insurance – A motion was made by Mr. Chubb and seconded by Mr. Kurt Kreider to approve student accident insurance for all Solanco students. Mr. Bender and Mr. Risk also voted yes on this motion, while Mr. Roten and Mr. Musser opposed. Under the School Code (Section 508), Five votes are required, regardless of absences and abstentions for "...Entering into contracts of any kind, including contracts for the purchase of fuel or any supplies, where the amount involved exceeds \$100." The motion failed.
