### Real Estate Taxes

2024/2025 Real estate tax invoices were mailed on July 1, 2024. If you have not received your invoice or received this invoice in error, please contact our office at 717-786-5611. Please remember if your mortgage pays your taxes, you must forward your invoice to mortgage company.

Millage for the 2024/2025 is 12.7604, to calculate base tax by multiplying current assessment X millage rate. Example \$100,000.00 X .0127604 = \$1,276.04

Homestead/Farmstead reduction for 2024/2025 is \$120.65, based on an assessed value of \$9,455.03per approved reduction.

## Interim Taxes

Changes to your property may result in an interim invoice. An interim invoice is typically for a change to a property that happens after the original tax bill has been issued on July 1<sup>st</sup>. Each invoice will outline the due dates for discounts, face and penalty payment amounts. Taxpayers must use the included envelope for payment or use the secure drop box at the administration building. Interim payments are not accepted at Fulton Bank.
